**Subject: MediHoney® CE-Marked Products Discontinuation**

Dear Valued Customer:

On April 2, 2025, we announced a voluntary global quality hold on all MediHoney® SKUs identified as part of our standard quality process.

Today we are announcing we also made the difficult decision to discontinue the Medical Devices Directive (MDD) extension for CE marked MediHoney® products (SKU's referenced in appendix). This decision is driven by the inability to perform regulatory changes as part of the MDD extension period and ongoing challenges with third party production.

This decision has been made after careful consideration and after extensive efforts to overcome these challenges. Any product that is already at external distribution centers or hospitals can be used.

We have already begun the process for removing our MDD extension and stopping the import of these products in Europe, Middle East and Africa. Please note that we are no longer taking orders.

We regret the inconvenience this announcement may cause you. We strive to provide notice and alternative care options to our customers, but due to the complexities and challenges of this product being manufactured by a third party we do not have such options. We recommend the use of alternative medical honey suppliers.

We appreciate and value our business relationship and look forward to your continued interest in Integra® products.
