Upcoming Product Discontinuation

LymphoTrack[®] Dx Assays – S5/PGM[™]

Dear Valued Invivoscribe Distributor,

As we approach the 26 May 2026 deadline for implementation of the EU IVDR 2024/1860, Invivoscribe is beginning to discontinue CE-IVD products that were labeled under IVDD Directive 98/79/EC. As a part of our IVDR transition plan, some less frequently used products will be discontinued in 2025. This letter is to inform you that Invivoscribe plans to discontinue sales of LymphoTrack Dx Assay – S5/PGM products on 30 April 2025. Please refer to Table 1 for a list of catalog numbers that will be affected. Please share the product discontinuation notice provided with your customers. To avoid issues with supply of these products, we encourage you to contact your Technical Account Manager and provide an anticipated forecast for your purchase/usage of these kits throughout the transition period. Please provide your anticipated forecast for the kits listed in Table 1 to Invivoscribe by 31 January 2025 so we may manufacture an appropriate number of kits in the final batch.
